

# New CDL Test Prep Program Sparks Overwhelming Interest

Last month, RIPTA announced a new Commercial Driver's License (CDL) Prep Course Program. This innovative CDL test prep course program, in partnership with the Rhode Island Institute for Labor Studies & Research (ILSR), is designed to attract and prepare new drivers in obtaining their CDL permit while

getting paid.

Participants have the opportunity to earn \$25.33 per hour as they prepare for their CDL permit test in an instructor-led classroom.

Over 200 people expressed interest in this new program at RIPTA's recent job fair on Tuesday, June 18. Both Rhode Island Current and NBC 10 reported on the overwhelming turnout. During the job fair, qualified applicants were able to participate in on-site interviews, receive conditional offers of employment and enroll in this new CDL test prep program.

## Key Features of the CDL Prep Course Program

- Earn While You Learn: Participants will receive \$25.33 per hour while studying for their CDL permit test.
- **Flexible Scheduling:** RIPTA and ILSR will work with your schedule to ensure you can balance your studies and personal commitments.

• **No Experience Necessary:** This program is designed for those who are new to the field and looking to start a career in transportation.

Applicants must be 21 years of age with a valid Rhode Island driver's license for at least three years and have a clean BCI. No experience necessary.

# New Pilot Program Enables Organizations to Jointly Fund Transportation for Low-Income Riders

Does your organization support low-income clients who are experiencing housing insecurity or are at risk of homelessness? RIPTA is seeking partners for a six-month pilot program to jointly fund transportation for these riders. Community-based organizations, state agencies, and collaborative partnerships are invited to submit applications for the program to pilot@ripta.com on a rolling basis. If approved, partners will receive a 50% discount on fare products for clients through institutional low-income pilot Wave accounts until December 31, 2024 or when allocated funds are exhausted, whichever comes sooner.

# Employee Spotlight

Stephanie LeFrancois, Night Foreman

RIPTA has been a part of Stephanie LeFrancois' family across generations. Stephanie's father,



Steven Robinson, worked as a Mechanic at RIPTA before he became a Mechanical Foreman. "My father convinced me to come here, and my father worked here for 37 years," she fondly recalls. Born and raised in Warwick, Stephanie is the Night Foreman, working from midnight to 8 AM to ensure that all bus routes and driver shifts are fully covered for the day.

Her career journey started in retail, working at Macy's as a stockroom employee for over six years. "I took a little time to spend some time with my kids and then I started with the school bus company," she remembers. Within a year, she acquired her CDL and gained enough driving knowledge to secure a job at RIPTA as a Clerk in the Transportation Division. After about six years of dedicated work in that role, she made the move up to her current foreman position, now in her second year.

With greater responsibilities come greater challenges - especially in the wake of a driver shortage. "The most difficult thing is choosing which jobs to cut because no matter what I cut, it's affecting people," Stephanie said. As the Night Foreman, she must decide which trips to cancel when there aren't enough drivers available.

Walking the property, marking down where the buses are, and assigning buses to drivers are all part of a typical work week for Stephanie. A sense of freedom is what she loves most about her job, and she hopes to move into a Relief Superintendent position in the future. It's clear that Stephanie is carrying on her family's legacy through her work in the Transportation Office.
