I've just found out from councilman John Goncalves that RIPTA's route 92 is about to be split, and its service on weekends will be completely canceled.

This will be quite unfortunate for me. I live near the Eastside Market end of this route, and there is a stop very close to home. Every Saturday, and sometimes on other days of the week, I play music with my friends on Federal Hill. I take route 92 from my home to Federal Hill and back. It is safe, direct, and convenient. It is especially helpful for me in snowy winter days, when driving is harder and less safe.

I also use 92 on the weekends for shopping in Trader Joe's and for dining and other fun activities with my family in the excellent Downtown and Federal Hill businesses, such as Sarto, Free Play Arcade, Providence Children's Museum, Somo Kitchen and Sushi, Sicilia's Pizzeria, and others.

If 92 in its current form is canceled, I'll have to take two buses, which will require walking a lot with a heavy digital piano or grocery bags. I hope that RIPTA can find a way to protect Route 92 and preserve full service to the East Side and Fox Point.

Dear Mr. Durand,

We, the undersigned, write to express our concern over proposed cuts to RIPTA services for the 2025-2026 budget year. Since the state legislature failed to provide requisite funds for RIPTA, the agency now faces a \$17.6 million budget shortfall and as a result, is considering massive cuts to services. Some of these routes will be eliminated, some will be shortened, and others will see reduced frequencies. Most routes in the RIPTA network are impacted in some way.

As public health researchers in Rhode Island, we know that many of the participants in our studies rely on public transportation to get to work, get groceries, access healthcare and indeed, and to get to study visits. Bus service is already not sufficient to meet the needs of people; some routes do not run that frequently. With further cuts, the consequences of missing a bus will be more severe; more missed appointments, missed days at work, school, etc. The people who use the bus include those on limited incomes, the elderly, the disabled – they all rely on these services that cannot be easily replaced. Taking an Uber is not a feasible, sustainable or accessible option.

These disruptions should not be taken lightly, especially when it comes to health care. There are people who take multiple bus routes for instance to get their daily treatment regimen for opioid use disorder. If a bus route is eliminated or service is reduced, this makes it more difficult for those people to get their care and puts them at risk to discontinue treatment. At the very least, studies have shown that cuts to bus service have led to decline in the mental health and wellbeing of impacted people as it impacts their ability to be social and meet with loved ones, in addition to accessing necessary services.

We urge RIPTA to reconsider making such drastic cuts and urge the state legislature to appropriate the necessary funds such that these cuts can be avoided.

Good morning,

I am reaching out to share my staunch opposition to the proposed RIPTA cuts. I previously attended the University of Rhode Island where I was enrolled in their Biotechnology program. The first year of classes required me to commute from the Kingston campus to the Feinstein campus in Providence every day. As a college student who couldn't afford to routinely pay for the gas required to make that commute for a whole school year, I relied on RIPTA's Route 66 bus to get me to where I needed to be, and was ultimately a much more cost effective option for me rather than driving. After the first week or so of classes, I noticed that more and more of my classmates were doing the same. It was just more efficient, and as a result, removed about a dozen individual commuters from the roadways, helping to ease the strain on our roadways, even if just a little bit.

I implore the governor to take another look at alternative means of funding to either eliminate the proposed service cuts entirely, or to minimize the proposed cuts to the best extent possible. Public transit is a cornerstone of connecting communities, servicing the disabled and elderly, as well as the less fortunate, not to mention the known positive environmental impacts. I cannot in good faith vote for Dan McKee in the future should these cuts be allowed to go through, and am willing to convince anyone I can to do the same.

Good morning,

I wanted to provide a comment on the proposed service reductions to Routes 3 and 4.

I understand the budget gap you are trying to fill and that reductions are necessary to close that gap. Eliminating Sunday Route 3 service is understandable because I'm sure the ridership is very low that day. I can also follow the logic for eliminating Route 4 weekend service.

However, I ask that you consider not doing frequency reductions on Routes 3 and 4 during the week--or at least during the morning and evening commuting times during the week. I live in Edgewood and take the 3 or 4 to and from my office in downtown Providence about 3 times a week. My husband and I only have one car, so the bus allows me to get to work without needing to get a second vehicle. If you reduce the frequencies in the morning and evening commuting times, it will be more difficult for me to plan the day and get to and from work and home in a reasonable amount of time, so I'd have to consider buying another car instead. And I'd rather keep taking the bus!

Thank you for considering my comment. I know you have a hard task ahead of you, and I appreciate everything RIPTA is doing to close the budget gap.

This isn't about any particular line, it's about having decent public transportation in Rhode Island's largest, and capitol, city.

I'm 75; I've been using public transit since I was in high school and took a bus to a volunteer job two towns away. I've lived in 8 different states and 14 different communities, and every time there was public transportation, I used it to get to work, to college classes, to graduate classes, to entertainment.


I HATE driving. I'd much rather take public transit. But what you're slowly strangling the system. The more you cut, the less people take buses because they can't rely on them, so you have excuses to cut more. The #1 bus runs so seldom now that I often don't take it (and it doesn't run to schedule). We can't take it to go downtown to go to shows at night, because it doesn't run late, so we have to drive. And park. And pay for parking. And walk.

I'd rather take a bus.

Other cities manage to maintain--and improve--transportation. When I lived in Arlington, VA, I commuted to my job in DC on a bus. DC now has a subway system, in addition to buses. When I lived in Jerusalem, buses were so cheap and so frequent that I'd just jump on any bus going in my direction, and jump off if it turned off before my destination, and got another. Jerusalem now has a subway system in addition to buses.

We're not asking for a subway, just an efficient, convenient, properly run bus system. Providence won't be a world-class city without one. And if we have one, more people might use the buses.

I'm writing to express my deep disappointment and frustration regarding the proposed cuts to Route 4, particularly the drastic reduction of weekday service and the complete elimination of weekend service. These changes are not just inconvenient, they are harmful and short-sighted, especially for those of us who rely on public transportation as a lifeline.

Route 4 is already limited, and making weekday service even more restrictive will have a severe impact on working people who depend on this route to get to and from their jobs. I, like many others, rely on this service to commute to work in order to survive in a state where wages have failed to keep up with the skyrocketing cost of living. Rent prices are outrageous, groceries are higher than ever, and taxes in Rhode Island are burdensome. The last thing we need is to lose access to one of the few affordable resources we still have.

It's incredibly disheartening that in a state that barely pays its workers a livable wage, RIPTA would even consider stripping away services that make it possible for low- and moderate-income residents to work, contribute, and live with dignity. While it's true that Route 4 passes through areas perceived as higher income, not everyone who lives along this route is wealthy, including myself. I already commute to Boston to find pay that reflects my experience and value, because Rhode Island refuses to pay its residents accordingly. Cutting this service just makes that struggle even harder.

Eliminating weekend service is particularly cruel. It isolates people who work weekends, those who visit family, run errands, or attend religious and community events. Are we just supposed to rely on Uber or Lyft, which can cost more than an entire day's wages for some? This proposal feels like yet another example of Rhode Island prioritizing wealthy individuals and corporations while pushing the rest of us further into the margins.

Public transportation is supposed to be for the public, not a luxury for when it's convenient or cost-effective for the state. If RIPTA wants to address a budget deficit, start by advocating for more equitable state funding instead of punishing the people who rely on you most.

Rhode Island needs to do better. Stop tossing its residents to the side like we're disposable. We deserve transportation we can rely on, not another reminder that the system only works for the privileged.

Please don't cut bus service to our Fox Point neighborhood! Please find a way to support bus transportation and keep this whole route running daily!

We have owned a small home in Fox Point for over 25 years, right on the 92 bus route, and the bus is a lifeline for us in so many ways. Our family uses it to get downtown to the library, to travel to work sites on weekdays and weekends, to attend cultural events, to shop, and to get to a part-time job at Rhode Island College. I do drive and I own a car, but I'm older and have had some injuries impairing driving, and I've relied on the bus during these times. My children are young adults with health issues who are both unable to drive, so they rely on the bus for job and school. Our son has learned independence and confidence by practicing the bus by himself. Also, as a family, we try to minimize driving--we walk, bike and take the bus whenever we can. We understand the impact cars and traffic congestion have on the climate of our city.

The proposed cuts to this route, splitting it and cutting weekend service, would affect our whole family directly.

Besides our family, we see so many of our neighbors of all ages relying on the bus each day. Some use it to get to work in the hospitals, some travel to school or downtown. Some are elderly, live alone, and use the bus as their only way to get around. The bus provides independence and dignity to the older residents of Fox Point and it's unfair to take it away.

Adequate public transportation in this lively, engaging, densely populated urban neighborhood is one of the most basic services we rely on. My name is Lola Rael, and I'm a resident of Cranston. I'm writing to voice my concern about the proposed service cuts. I've been a frequent RIPTA rider since I was old enough to take the bus independently. At many points in my life, RIPTA has been an invaluable resource to me and my primary transportation around Providence and the surrounding area. I've commuted to work daily for years using the 1, 3, 4, and R lines, but I rely on the full bus network regularly.

The proposed service cuts, mainly the reduced frequency and the elimination of some weekend service, would make it significantly harder for me to get to work, especially since I work every Saturday and Sunday in addition to weekdays. More generally, these changes would make it much more difficult to live a car-free lifestyle in the Providence metro area. For me, this is a choice rooted in values. But for many Rhode Islanders, especially low-income individuals, seniors, and people with disabilities, public transit is the only option.

While these changes will inconvenience me personally, I'm more concerned about their bigger social consequences. Reliable public transit improves social equity, economic opportunity, and quality of life. Service cuts will further isolate people who already face barriers, deepen the divide between those who can afford to drive and those who cannot, and increase reliance on cars, which contribute to traffic, environmental harm, and DUI incidents.

Please reconsider these cuts and prioritize long-term solutions that strengthen, rather than weaken, transit access in Rhode Island.

I am writing to strongly oppose the proposed elimination of Route 69, the Flex on-demand service, and other major cuts to RIPTA's transportation system.

As a Rabbi, URI affiliate, and Chaplain and Advisor of the Chabad Student Club, I see firsthand how deeply these services impact students, international workers, seniors, vulnerable populations, and the broader community. URI already faces severe parking shortages, with students circling lots, missing class, and struggling to find options—especially those who live off campus, which includes many non-freshmen due to limited housing. RIPTA is not a luxury; it is vital.

The Flex on-demand service, in particular, is the kind of innovation we need more of—not less. Expanding, not eliminating, this model would be a step toward better accessibility and efficiency. It offers critical service to communities where fixed-route service isn't viable and helps fill serious transportation gaps.

While I'm not normally in favor of raising fares on the public, charging riders an extra 25¢, 50¢, or even 75¢ is far preferable to gutting the system altogether. Fares haven't gone up since 2010. Find me any other good or service that hasn't increased in 15 years. Even with an increase, RIPTA's fares would still be lower than many comparable systems across the country. RIPTA has and could have programs to subsidize fares for people who truly can't afford the bus, ensuring continued access for the most vulnerable.

The 2¢ increase in the gas tax that generated \$15 million shows the potential of even modest adjustments. A few more cents could preserve and strengthen the system—especially when compared with the devastation these cuts would cause. Rhode Island leaders say they care about climate change and reducing car use, but cutting public transit is the opposite of that. It is climate hypocrisy, plain and simple.

The state's vehicle inspection requirements are perhaps the most draconian in the country, making it often burdensome to keep a vehicle on the road, despite little to no data that safety is increased because of this. Now, they want to cut public transportation too!

We need real solutions, not short-sighted cuts. That includes:

A modest fare increase, with subsidies for those who need them

Another small increase in the gas tax

Progressive taxation of the wealthiest Rhode Islanders

Prioritizing essential services over government waste

Let's be honest: there's far more wasteful spending elsewhere in government. Why not redirect those funds to support a service that's essential to education, the local economy, mobility, equity, and the environment?

Cutting RIPTA now would be a long-term mistake. This proposal fails to meet the needs of the people who rely on transit every single day—and undermines our collective future.

To those fighting to maintain our state's bussing, thank you!

I want to tell you two stories about how RIPTA changes our lives.

One of our friends was struggling with severe PTSD and depression in Massachusetts, to the point that they couldn't keep up with life. Their car broke down, and they got let go at work any and then evicted from their apartment. They had to quickly start over, moving to an even more remote part of Massachusetts to lean on extended family and just keep putting one foot in front of the other. The thing that kept them going was a vision of moving to Providence and connecting with the LGBTQ+ community, the arts, and the vibrancy of this city. They kept at it, knowing that they could be fulfilled and surrounded by love if they could afford to move here. This beautiful new life they've built over the last two years—helping people, making art, showing kindness and joy to all—will implode if they cannot take the bus to work, medical appointments, and social activities. Providence was a shining city on the hill to them, and that vibrant community that drew them in is SO reliant on RIPTA's current routes that it could become unrecognizable within a year. The city will become congested with traffic, more dominated by parking structures than attractions and businesses. It will become a monoculture where certain classes can visit or spend time, and they will quickly tire of it when the spark dies of the creative force and maintenance labor of the working class. People will be stranded in the city unable to pickup kids from school, they will spend all their time trying to get downtown and lose their jobs, employers will struggle to fill positions. And for my friend and others like them, they will not be able to afford to live here and contribute here within months.

The next one is a love story. My partner lived a 45 minute drive away as my health failed me, and she drove up every chance she could to help me with medical care and just get me out and about to maintain some small quality of life. One day her car broke down, and I was heartbroken that I would have to adjust to my diagnosis and dwindling physical ability as a shut-in, struggling to take care of even simple things. Instead, she took the bus. RIPTA delivered my loving partner twice a week so we could be together and "be there" for each other in ways we could not over the phone or video chat. I am crying as I write, because I don't know how I would have gotten through that time without her. We are so thankful for RIPTA, and we would be crushed to know the route she took would be closed down to everyone else who needs it.

Please fight for what's right and save our state from becoming fractured, beleaguered and stagnant due to lack of affordable transportation.

For everyday working individuals like myself, I use the bus 5 days a week to get to work in the city. I once drove in myself, but with parking garages and lots that were overpriced or didn't open early enough and some of the worst city street parking I've seen in the country, I couldn't afford to spend a huge fraction of my minimum wage paycheck to cover parking costs and parking tickets. Did you know you cannot park on the same street for more than 2 hours in downtown, even if you pay the meter on time? In someone's deluded fantasy, as an employee in downtown who relies on street parking, you're expected to leave your job every two hours for 15 minutes, and move your car to a different street in a different parking spot. Even if you moved a few spots down the same street, you'll still get a ticket for it. With a place as small as Rhode Island, the infrastructure for cars as is is absolutely horrendous, some of the worst in the country in fact (including parking laws where majority of other cities aren't nearly as deluded) we can't afford to swallow up more space just to store cars.

That's when I started taking the bus. It was to the point where driving and parking in downtown was so bad, I considered just finding a new job just to save money and the constant stress of tickets and parking fees. But thanks to the buses, I didn't have to uproot my life just because the laws and build of the city made driving my car to and from work a nightmare. The buses were reliable, easy, and AFFORDABLE transportation to get to and from work. Cutting RIPTA routes not only screws over everyday working people like me, but our most vulnerable in the community that our government swore to protect, not line the interest of the top percent and corporations. Not to mention with nearly 30% of the population being considered impoverished, those who truly can't afford the cost of cars, you would ultimately be killing most of our life line to work, school, and grocery stores. What's the plan then? Leave the rest of us stranded to fend for ourselves? Walk hours to work and school with the worst drivers in the country threatening to strike us at any point with their reckless driving? What about the school children who's only way to and from school is the bus system? The rest of us get screwed over then?

Cutting RIPTA funding and routes is about the stupidest thing this city could do. You do not have the space or infrastructure to be a car centric city, and you're screwing everyone over just to pretend like you are. Those of us working, disabled, impoverished need more programs that work for us in our favor, not against. This is not in our best interest, and I'm not sure who it's meant to serve, but I imagine this will leave a sour taste for all of us in the voting booths.

Route 92 serves many purposes for residents along its route. For a particular community of Fox Point seniors frequently using this line, there is no viable alternative transport available to them. They are using the line to get to doctors and to buy groceries, among other things. They cannot simply walk or call a taxi given their advanced ages and minimal budgets. For these people and other regular commuters, the 92 line is vital. For other people in the area, including people like me walking across the river on the footbridge to connect by short hops to shopping and cultural sites, the line presents a valuable convenience.

Reducing service and confusing the routing of the remaining service on route 92 seems like change that looks reasonable on paper that reveals itself to be disastrous once the actual people involved enter our considerations. If RIPTA hurts for funding to such an extent it cannot support the kind of baseline public-transit service route 92 and others like it provide, we need to rearrange our funding priorities. Perhaps RIPTA should petition the city and the state to spend less money installing intrusive (indeed, unconstitutional) and minimally helpful surveillance cameras all over Providence, and to cut the babysitting of private building-construction and utility-crew workers by uniformed city police (essentially the only time we see police in the flesh anymore - what, with all the cameras to monitor on expensive software on station-based computers - outside of riot-duty staffing for peaceful protests by groups not aligned with the far right). Maybe I am crazy, but providing public transport to the people who need it most seems to me to be a high priority for any city.

Please reconsider this needlessly harmful change to route 92 - and to comparable service lines around the city. We need better bus service, not less bus service.

No one objects to rationalizing the service map or to minding overall budgets. We cannot afford, however, to make single-service lines part-time services in communities with struggling residents who deserve better. The seniors alone make this line worth fighting for, but 92 serves multiple needs. The people are the bottom line for such a service. RIPTA exists to serve its community, not a corporate bottom line. All our decisions in local government turn on such considerations. This decision to cut service on route 92 needs rethinking, while the mistake can be corrected without injuring or inconveniencing anyone.

Good morning!

I'm writing to express my strong opposition to the proposed service changes on the 69 and 65x routes serving South Kingstown. As a RIPTA rider for more than 30 years, I depend on accessible public transit to get to work and get around town. I have peripheral neuropathy and have not driven since 2016. Many of my fellow riders on the 65x choose RIPTA for cost and convenience, or for the environmental benefits of taking cars off the road to Providence. All are important reasons to support a strong, robust public bus service. My own situation, however, is more complicated.

I usually take the 65x from the 138/1 park and ride - my wife can drop me off on her way to work at a local elementary school. If this route is eliminated, I'd have to take the 66 from Kingston Station or URI to get to work in Providence. However, if the 69 route is eliminated as well, SK will have NO public transportation to get to the capital city. This is simply unacceptable... I've often taken the 69 from Main St in Wakefield to Kingston to pick up the 66, but if this is no longer an option, the only choice would be to Uber - and Uber is neither affordable nor readily available.

From a broader perspective, RIPTA's proposed cuts threaten the core of our statewide public transit system. We're not cutting fat here - these cuts affect muscles, ligaments and bone! Longer intervals between buses, the elimination of park and ride routes, and widespread uncertainty about the future will lead to a death spiral for public transit ridership in our state. I urge you to work with the governor's office, the RI Department of Transportation, and other agencies to identify alternative sources of revenue. These cuts are devastating, and once made, RIPTA will be a shell of itself. We can't let that happen - too many Rhode Islanders depend on affordable, quality public transit. RIPTA is efficient, but perennially underfunded. Let's stop the bleeding now!
